#### **CHAPTER I**

# **INTRODUCTION**

This chapter discusses the background of the research, identification of the problem, limitation of the problem, formulation of the problem, objectives of the research, and significance of the research.

#### A. Background of the Research

The pandemic is caused by Coronavirus in Indonesia, many strategies have been taken by the government to prevent its spread. At this time the world is faced with an outbreak of a disease caused by a virus known as Coronavirus Diseases or known as Covid-19. The impact of Covid-19 in Indonesia is currently quite large for the entire community. The policies that have been issued by the government have had a large impact on aspects of life, especially in the aspect of education in Indonesia. In this case the students problem in writing indicators are content, vocabulary, language use, and mechanics.

Writing consists of various genres such as description, exposition, argumentation, and narration. Narrative text is a type of text to retell the story of past events. Narrative text has events that are told in words. The sequence always involves structured timing. In a narrative text, every student should understand a generic structure to produce good and correct writing. These components should be present in a narrative text because they are the main characteristics of writing. If students can write narrative text based on existing generic structures, meaningful students can understand the narrative text well. Narrative text is a form of story text that has the aim of entertaining the reader. This means that narrative is a text that focused on a particular participant. Narrative text is one of the texts that students must master.

Based on the information obtained by the researcher on the English learning process carried out at SMK N 1 Pacitan, the researcher has identified several problems related to learning to write. Students have difficulty in writing skills based on writing indicators especially of content, vocabulary, language use and mechanics. Narrative text has several components such as social function, generic structure, language characteristics, and others. Students can identify generic structures, but some students have not been able to determine parts of the generic structure of the narrative text. English is a foreign language, not the primary language in daily communication, so students have deficiencies in mastering vocabulary. The last one is that less than reading activities make students have weaknesses in expressing an idea correctly. Learning carried out using the internet network makes students lack motivation, especially in learning to write.

Researcher wanted to prove that students have difficulties in writing ability.
